

BIPA CHARTER

Purposes

The Business Information Providers Association (BIPA) exists for a number of purposes:-

- To protect the availability of and access to publicly available and regulated business information and data
- To promote the further controlled public release of business information and data
- To protect and improve the quality of that data wherever possible
- To act as a primary source of information on the industry and to facilitate communication with legislators, regulators and the wider business community.
- To protect the interests of its members and their customers
- To promote and protect the wider interests and image of the industry as a whole

Governance

To fulfill its purposes a management group comprising appropriate representatives of all BIPA's members meet on a regular basis to discuss pertinent issues. Decisions are made by consensus and each member has a single vote. A competition law compliance policy is in place and no commercial issues are discussed at BIPA meetings. BIPA is governed by an agreed set of statues which can be made available on request.

Activities

BIPA makes itself available to meet with legislators, regulators and other policy influencers as well as business and trade associations and bodies to discuss matters of interest and relevant to BIPA's purposes. BIPA reacts to appropriate public consultations and discussion papers.
